## WHAT IS THE INDIAN CHILD WELFARE ACT OF 1978?

The Act is a law designed to protect the best interests of Indian children and to promote the stability and security of Indian Tribes and families.

The objective of this Indian Child and Family Services Program is to prevent the break-up of Indian families and, in particular, to insure that the removal of an Indian child from the custody of his parent or Indian custodian is a very last resort.

#### WHO CAN BENEFIT FROM THE SER-VICES PROVIDED UNDER THIS LAW?

All Indian children and their families who are members or are eligible to be members of Federally recognized tribes.

### WHAT SPECIFIC BENEFITS ARE AVAILABLE?

Guidance, legal representation, and advice to Indian families involved in tribal, State, or Federal child custody proceedings:

- Voluntary child custody proceedings. Generally adoptive situations insuring that certain standards and conditions are met.
- Involuntary child custody proceedings relating to adoption or foster care: as in cases of neglect, abuse, or other situations where there are grounds for permanent termination of parental rights.
